On behalf of the West River Estate & Financial Planning Council Executive Committee, I would like to welcome you to our 2025 seminar luncheon series. We are excited to offer the seminars at the Journey Museum, 222 New York Street in Rapid City. Our lunches will be catered by Fork Real. We have some great speakers who have committed to presenting!

Enclosed you will find the 2025 WREFPC brochure which features the speakers and topics presented this year. We also encourage you to invite guests to attend any of the seminars; we just ask that you register for the guest beforehand, and each guest will be additional cost of \$30 per guest (lunch included), per seminar.
